ORDINANCE NO. 1989-5

AN ORDINANCE AMENDING ORDINANCE 82-1 REQUIRING THE OWNERS OF REAL ESTATE WITHIN THE BOROUGH TO PROVIDE WRITTEN NOTICE OF TENANTS TO THE BOROUGH SECRETARY AS WELL AS THE BOROUGH TAX COLLECTOR.

BE IT ENACTED AND ORDAINED by the Borough Council, Council of Goldsboro Borough, York County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same as follows:

SECTION 1: Ordinance No. 82-1 entitled:

AN ORDINANCE IMPOSING A DUTY UPON OWNERS OF REAL ESTATE WITHIN THE BOROUGH OF GOLDSBORO WHO RENT SUCH REAL ESTATE TO PROVIDE THE BOROUGH TAX COLLECTOR WITH THE NAMES OF ALL RESIDENTS OF SUCH REAL ESTATE AND PROVIDING FOR PENALTIES FOR THE FAILURE TO COMPLY WITH THE ORDINANCE.


is hereby amended to provide that in Section 1, Section 2 and Section 4, the information requirement of the Ordinance shall be provided to the Borough Secretary as well as the Borough Tax Collector within the same time periods and in the same manner as set forth in Ordinance No. 82-1.

SECTION 2: In all other respects, Ordinance No. 82-1 is reaffirmed and ratified.




