ORDINANCE NO. 1989-6

AN ORDINANCE REPEALING ORDINANCE 1987-4 WITH REGARD TO ANGLE PARKING ON THE WEST SIDE OF NORTH YORK STREET.

WHEREAS, Borough Council had previously enacted Ordinance No. 79-3 entitled AN ORDINANCE ESTABLISHING ANGLE PARKING ON THE WEST SIDE OF NORTH YORK STREET, and

WHEREAS, Ordinance No. 79-3 was amended by Ordinance No. 1987-4 to require angle parking only during certain periods of time and on certain dates, and

WHEREAS, Borough Council desires to repeal Ordinance No. 1987-4,

NOW THEREFORE, BE IT ENACTED AND ORDAINED by Borough Council of Goldsboro Borough, York County, Pennsylvania, it is hereby enacted and ordained by the authority of the same as follows:

SECTION 1: Ordinance No. 1987-4 is hereby repealed and any other prior Ordinance or part thereof which is inconsistent with Ordinance No. 79-3 shall be, and is hereby repealed to the extent of such inconsistency.

SECTION 2: Ordinance No. 1979-3 is hereby reaffirmed.

SECTION 3: This Ordinance shall become effective on

the 1st day of January, 1990.

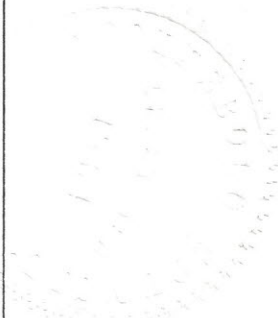
