

GOLDSBORO BOROUGH

ORDINANCE NO. 1993-1

AN ORDINANCE REGULATING PARKING OF CERTAIN SIZE VEHICLES ON STREETS, ALLEYS, AND HIGHWAYS OF GOLDSBORO BOROUGH, YORK COUNTY, PENNSYLVANIA, PRESCRIBING PENALTIES FOR THE VIOLATION THEREOF.

**BE IT ENACTED AND ORDAINED**, by the Borough Council, Goldsboro Borough, York County, Pennsylvania and it is hereby enacted and ordained by the authority of the same as follows:

**SECTION 1:** By authority granted by section 3353(d) of the Pennsylvania Vehicle Code, and 67 PA Code Section 201.21(e), it shall be unlawful for any person or persons to park any vehicle in excess of one (1) ton capacity on a public street, alley, or highway within Goldsboro Borough, York County, Pennsylvania, which said streets, alleys, or highways are situated within any of the following zones, as defined by the Goldsboro Borough Zoning Ordinance, Ordinance No.1987-3: **Residential, Residential Limited, Residential-One Family, Residential Agricultural, Village, Commercial, and Conservation**, except for vehicles making local deliveries which said vehicles may be stopped or parked for temporary purposes while such vehicles are actually engaged in loading or unloading, for a period not to exceed three (3) hours of duration.

**SECTION 2:** Any person who violates any of the provisions of this Ordinance shall, in a summary proceeding before a District Justice, be sentenced to pay a fine of not less than \$50.00 nor

more than \$600.00, together with costs of prosecution, and in default thereof, to undergo imprisonment in the York County Prison for a period not to exceed thirty (30) days. Each day that the violation shall continue shall be a separate offense and shall be punishable as such.

**SECTION 3:** Fines and costs imposed under the provisions of this Ordinance shall be enforceable and recovered in the manner provided by applicable law.

**SECTION 4:** It is declared that the enactment of this Ordinance is necessary for the protection, benefit, and preservation of the health, safety and welfare of the inhabitants of Goldsboro Borough.


**SECTION 5:** It is the intention of the Borough Council that each section or portion of any section of this Ordinance shall be a separate provision and all shall be independent of all other provisions herein, and it is further the intention of the Borough Council that if any section or portion of any section shall be declared to be unconstitutional, invalid, illegal, or unenforceable by any Court of competent jurisdiction, such decision shall not affect the validity of any of the remaining sections or parts of this Ordinance. It is hereby declared as a legislative intent that this Ordinance would have been enacted had such unconstitutional, invalid, illegal or unenforceable provision not have been included herein.

**SECTION 6:** All Ordinances or parts of Ordinances which are inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.


**SECTION 7:** This Ordinance shall be and become effective immediately upon its adoption.


