RESOLUTION CONSENTING TO ASSIGNMENT OF FRANCHISE

WHEREAS, York Cable Television, Inc. t/d/b/a Cable TV of York has signed a letter of intent to acquire all of the assets of TCI of Pennsylvania, Inc. relating to the cable television system located in Goldsboro Borough;

WHEREAS, upon closing of the acquisition, all right, title and interest of TCI of Pennsylvania, Inc. in the franchise granted by Resolution 1992-1 dated July 13, 1992, shall be assigned to York Cable Television, Inc.; and

WHEREAS, York Cable Television, Inc. is respectfully requesting that the Borough consent to such an assignment of the franchise to York Cable Television, Inc.;

NOW, THEREFORE, the Borough of Goldsboro states as follows: 1. The Borough of Goldsboro consents to the assignment of the franchise from TCI of Pennsylvania, Inc. to York Cable Television, Inc. and the release of TCI of Pennsylvania, Inc. from any further obligations or liability thereunder; provided that York Cable Television, Inc. deliver to the Borough a written acceptance of all the terms and conditions of Resolution 1992-1 and that such consent shall become effective only upon the closing date of such transfer and it shall be further provided that if TCI of Pennsylvania, Inc. delivers a notice that the acquisition contemplated by this Resolution will not be consummated, this Resolution shall be void and of no further effect.

2. The Borough hereby confirms that (i) the Franchise was properly granted; (ii) the Franchise is in full force and effect; (iii) the Franchise is scheduled to expire on September 10, 2007; and (iv) to the Borough's knowledge there exists no fact or circumstance which constitutes or which, with the passage of time or giving of notice or both, would constitute a default under the Franchise or will entitle the Borough to cancel or terminate the rights thereunder, except upon the expiration of the full term thereof.
