

**FEE RESOLUTION** 2001-1

A resolution establishing fees for the filing of applications, permits, and licenses for the Borough of Goldsboro.

*WHEREAS*, the Borough Council of the Borough of Goldsboro has adopted a codification, consolidation, and revision of the ordinances of the Borough; and

*WHEREAS*, it is the desire of the Borough Council of the Borough of Goldsboro to eliminate all filing fees, permit fees, and license fees from the Code of Ordinances and enact them instead by resolution; and

*NOW, THEREFORE BE IT RESOLVED THAT* and it is hereby resolved by the Borough Council of the Borough of Goldsboro that all fees are hereby fixed as follows:

<b>SUBDIVISION AND LAND DEVELOPMENT</b>	
Submission of subdivision and/or land development plans	\$250.00
Pursuant to §804 of Goldsboro Borough's Subdivision and Land Development Ordinance, the Council of Goldsboro Borough hereby establish that the fee for the submission of any and all plans to be reviewed pursuant to the Subdivision and Land Development Ordinance shall include the cost of administering, processing and reviewing of plans, the inspection of public improvements, the preparation of their cost estimates, and any contingent legal services.	
These costs shall be billed to the applicant at the completion of each review phase and shall be in accordance with the ordinary and customary charges of the Borough Engineer or legal consultant, but in no event shall any such fees exceed the rate or cost charged by the Engineer or legal consultant to the Borough of Goldsboro when such fees are not reimbursed by or otherwise imposed upon applicants under the Subdivision and Land Development Ordinance.	
The imposition of these review fees shall be governed by, including, but not limited to, the Borough's Subdivision and Land Development Ordinance in effect at the time of the application, and the Municipalities Planning Code, §10101, <i>et seq.</i>
