

RESOLUTIONS BY THE BOARD OF SUPERVISORS OF NEWBERRY TOWNSHIP AND THE BOROUGH COUNCILS OF THE BOROUGHS OF YORK HAVEN, GOLDSBORO, AND LEWISBERRY, YORK COUNTY, PENNSYLVANIA, ACKNOWLEDGING AGREEMENT OF CONTINUED SHARED POLICE SERVICES AND THE COMBINED PURSUIT OF FUNDING TO PAY FOR NEW POLICE RADIOS.

WHEREAS, the Newberry Township Police Department provides 24/7 police services to the residents of Newberry Township. Newberry Township also has ongoing inter-governmental agreements with the Boroughs of York Haven, Goldsboro, and Lewisberry to provide 24/7 police services to each of those three municipalities. These agreements have existed for several years and are continuing. Including all four municipalities, the total population served by Newberry Township Police is 16,465.

WHEREAS, The County of York provides all police radio dispatching for Newberry Township Police (and all municipal police departments in the county as well). York County is upgrading its entire emergency radio system. As a result, Newberry Township is required to purchase all new radios for the police department in 2007. The total cost for the radios is \$90,806.10.


WHEREAS, Newberry Township has been approved for matching funds from York County in the amount of \$69,857.03. This leaves a remaining balance, which Newberry Township is responsible for, of \$20,949.07.

WHEREAS, Newberry Township and the Boroughs of York Haven, Goldsboro, and Lewisberry agree to request funding assistance from the Commonwealth of Pennsylvania in the amount of \$20,900.00 to pay for the new police radios.
