**A RESOLUTION OF THE BOROUGH COUNCIL FOR THE BOROUGH OF GOLDSBORO,  
YORK COUNTY, PENNSYLVANIA, HONORING NEWBERRY TOWNSHIP POLICE CHIEF  
DAVID W. DUFFY FOR HIS SERVICE.**

**WHEREAS**, David W. Duffy was hired as Police Chief for Newberry Township, York County, Pennsylvania, in April 2003; and

**WHEREAS**, prior to joining the Newberry Township Police Department, Chief Duffy served in the Police Department with the Doylestown Township Police Department; and

**WHEREAS**, soon after joining Newberry Township Police Department, Chief Duffy expanded his professional horizons by being selected for the FBI National Academy, which is a professional course of study for U. S. and international law enforcement leaders that serves to improve the administration of justice in police departments and agencies at home and abroad, and to raise law enforcement standards, knowledge, and cooperation worldwide; and

**WHEREAS**, during his tenure with the Newberry Township Police Department, Chief Duffy applied the skills he developed through years of professional service and knowledge he gained at the FBI National Academy, and in doing so enhanced the services and professionalism of the Newberry Township Police Department, to the great benefit of residents of Goldsboro Borough and surrounding communities; and

**WHEREAS**, Chief Duffy has been involved in many law enforcement and community organizations, and is a member of the Pennsylvania Chiefs of Police Association, the International Association of Chiefs of Police, the York County Chiefs of Police Association, the Central Pennsylvania Chiefs of Police Association, and the FBI National Academy Association.
