RESOLUTION NO. 2010-1

**A RESOLUTION OF THE BOROUGH COUNCIL OF GOLDSBORO
BOROUGH, YORK COUNTY, PENNSYLVANIA, APPOINTING DEBRA
POPP AS AGENT OF THE GOLDSBORO BOROUGH COUNCIL FOR THE
COLLECTION OF THE PER-CAPITA TAX AND REAL ESTATE TAX.**

WHEREAS, the person elected to the Office of Tax Collector for Goldsboro Borough ("Borough") at the November 2009 municipal election declined to accept the elected position, which has created a vacancy in the Office of Tax Collector; and

WHEREAS, a vacancy in the Office of Tax Collector exists and no resident of the Borough has within thirty (30) days received and accepted the appointment to fill such vacancy; and

WHEREAS, pursuant to §902 of the Borough Code, 53 P.S. §45902, the Borough Council is empowered with collecting taxes for the Borough when a vacancy in the Office of Tax Collector exists; and

WHEREAS, the Borough Council desires to appoint Debra Popp as its agent for the collection of per-capita tax and real estate tax levied by the Borough; and

WHEREAS, Debra Popp has agreed to act as agent for the Borough Council for the collection of per-capita tax and real estate tax levied by the Borough.

NOW, THEREFORE, be it resolved by the Borough Council of Goldsboro Borough, York County, Pennsylvania, as follows:

1. Debra Popp, of 1909 Old Trail Road, Etters, Pennsylvania 17319, is appointed agent for the Borough Council for the collection of per-capita tax levied by the Borough pursuant to the Local Tax Enabling Act, 53 P.S. §6901, *et seq.*, and real estate tax levied by the Borough pursuant to the Borough Code, 53 P.S. §45101, *et seq.* Debra Popp's appointment as agent for the Borough Council for the collection of per-capita tax and real estate tax shall become effective January 1, 2010 and shall expire December 31, 2013, unless a qualified elector who resides within Goldsboro Borough is elected to fill the vacancy in the November 2011 municipal election, and said qualified elector accepts said election results, in which case Debra Popp's appointment as agent herein shall expire on the first Monday of January 2012 when such person would be sworn in and assume the Office of Tax Collector for the Borough.

2. As agent for the Borough Council, Debra Popp shall be vested with all rights, duties and obligations as Tax Collector for Goldsboro Borough as set forth in the Borough Code, 53 P.S.

§45101, et seq., the Local Tax Collection Law, 72 P.S. §5511, et seq. and any other applicable act or law, which are incorporated herein by reference.

3. In each tax year in which Debra Popp serves as agent to the Borough Council for the collection of per-capita tax and real estate tax, the Borough shall pay to Debra Popp a sum equal to five percent (5%) of the per-capita tax revenue and real estate tax revenue which Debra Popp collects on behalf of the Borough Council during that tax year pursuant to the authority granted herein. The Borough shall also reimburse Debra Popp each tax year for the cost of postage, mailing, printing, or otherwise, which is directly attributable to the collection of per-capita tax and real estate tax on behalf of the Borough Council, as provided herein.

4. Debra Popp shall provide the Borough with a bond, for the faithful performance of her duties as agent for Borough Council for the collection of per capita and real estate taxes, as provided for herein. The bond required herein shall be with a surety company authorized by law to act as surety in the Commonwealth of Pennsylvania. The Borough may pay the premium for said bond, including a proportionate share of the cost of the bond, such share to be in the same ratio as the amount of Borough taxes bears to the total amount of all taxes indicated in the tax duplicate or duplicates to be collected by Debra Popp during the year preceding the date the premium is due.
